Principal's Report (J. Harris) - 7:08 PM

- Currently 926 students enrolled
- 2 teachers got married and one got engaged
- Staff are working together to create mentorship time amongst themselves with the support of admin.
- Power of Connection is emphasized with and staff and the students – it's difficult for students to learn if they don't feel connected
- Poppy is looking to create an optimal environment for all students to flourish
- Student Assembly – recently grade level assemblies were held for all students to set clear expectations for the year
- Cell Phones / air pods / apple watches – per ministry requirements they are to be put away and turned off. But if on occasion additional tech is needed in the classroom the teachers may ask students to use their phones
- Recently held a successful Spirit Week and raised money for the Terry Fox Foundation with 'Pie in the Face' of some teachers/admin
- Building Projects around the school
 - o Benches, new flooring on the first floor, new flags, lockers painted, red zone painted, logos around the school, cafeteria space (wanting a new name!), waiting for 30 more chairs for cafeteria
 - o Old grad photos were taken down, but will be hung again. All were scanned, as well as all yearbooks, and will be available for viewing digitally.
- Projects for 2025/26
 - o Roofing completed, phase 2 of the front of school, painting the school, fields serviced 2x's per year, new computer lab completed, new technology added (110 new laptops added. New video cameras)
- Principal Harris confirmed that the semester turnaround days are on the Poppy school calendar
- Last day of classes is June 18th
- Garden area in front of the school is part of phase 2
- Soaps back in the washrooms
- Emergency Evacuations
 - Met with district to debrief
 - Two threats were deemed low risk by RCMP
 - Communications to families released in collaboration with RCMP - which tends to be vague
