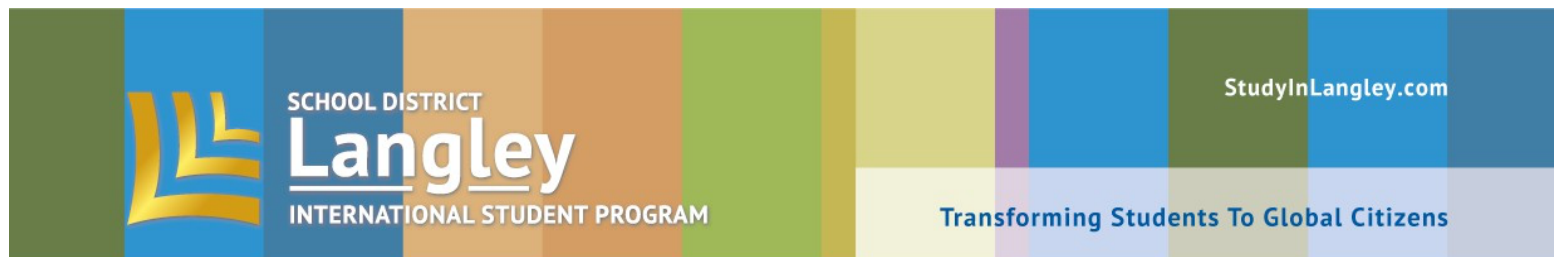

Travelling with a Natural Parent Checklist

The following information is included in the application:

- ☐ Signatures of Natural Parent, Homestay & School Coordinator
- ☐ Student's plane ticket or airline confirmation (if applicable)
- ☐ Natural parent's plane ticket or airline confirmation
- ☐ Natural Parent ID, if name does not match parent name in True North
- ☐ A letter from Natural parents stating that the student can travel alone from YVR to natural parent, if flying alone for part of the trip
- ☐ Proof of additional insurance (students on MSP, if travelling out of BC)
- ☐ I have checked the expiration dates of all relevant travel documents listed below. The documents do not expire in the 3 months prior to my return date.

The student must take the following on the trip:

- BC Medical Card
- Study Insured Card (valid in Canada & US)

In addition, if flying and/or travelling out of Canada the student must take the following valid documents:

- Passport
- Study Permit
- LOA
- If flying to meet the Parent, a Letter from Natural parents stating that the student can fly alone and/or to the US (out of Canada)
- Travel visa, if necessary
- Custodian document
