Shelter Committee – Susan, Jen, Jodi, Nicole, Laura & Mrs. Tarasoff

- Alliance has confirmed they are giving us \$25,000 for the shelter. PAC has paid a deposit of \$8200, from a budget line of \$10,000. The largest structure that covers the entire gravel area is just shy of \$50,000. PAC would need to add ~\$15,000 to cover the remaining cost. Laura estimates that \$5000 could come from our Gaming budget, and \$10,000 can come from our Main
- Next steps: building permit from the Township, approval from CUPE for Atlas Sun Systems to install instead of District Maintenance.
- Laura motioned to add budget line of \$5000 to Gaming Budget and additional \$10,000 to Shelter Cover line in our Main Budget. Seconded by Amy. All in favour.

Fun Fair Committee

- Committee meeting will be happening after the PAC meeting this morning.
- Order forms will be sent out by the end of the month. There will be no pre-sales for concession again this year.

- BC Events deposit paid in the fall, received 15% discount. Looking at adding 9 hole mini golf as an activity, in addition to bouncy castles, climbing wall, and swing ride. Adding golf would cost an additional \$350 but this would still work within our budget due to the 15% discount received. Entire BC Events cost is \$5718.30
- Looking at adding Wild Education as a ticketed item, to help with the lines/number of people in that space.

Old Business:

- Emergency Supplies (Jodi): tabled to September.
- Swimming lessons: tabled until next month.
- Book Fair: in person Book Fair will not be happening this year. Question was raised about budget line for books for teachers instead. PAC agreed to still give each teacher \$50 for classroom books. Jodi to send out information to teachers.
- Scholarships: PAC is giving one \$500 scholarship to a former Shortreed student graduating this year. Application deadline April 30, to be voted on at AGM.

New Business:

- Movie Night: May 3, looking at options for movies. Notices/pizza order form coming out soon.
- Dollar Sale: Friday April 26th, donations accepted starting April 15. Sign-up for volunteers coming out soon.
- Proposed Budget for 2024/2025:
 - Most of budget is same, majority of increases are for additional division.
 - Decreased bus amount for classes, as this budget is rarely used.
 - Gaming grant estimated to be \$8500 next year
 - Laura motioned to approve proposed budget as presented, seconded by Shaunee. This will be voted on at the AGM next month.
- Nominations are open for 2024/2025 PAC Executive. PAC Executive is dissolved at the end of June and new Executive is elected. You can self-nominate or nominate someone else! More than one person can be nominated for a position. Positions are voted on at the AGM.
